

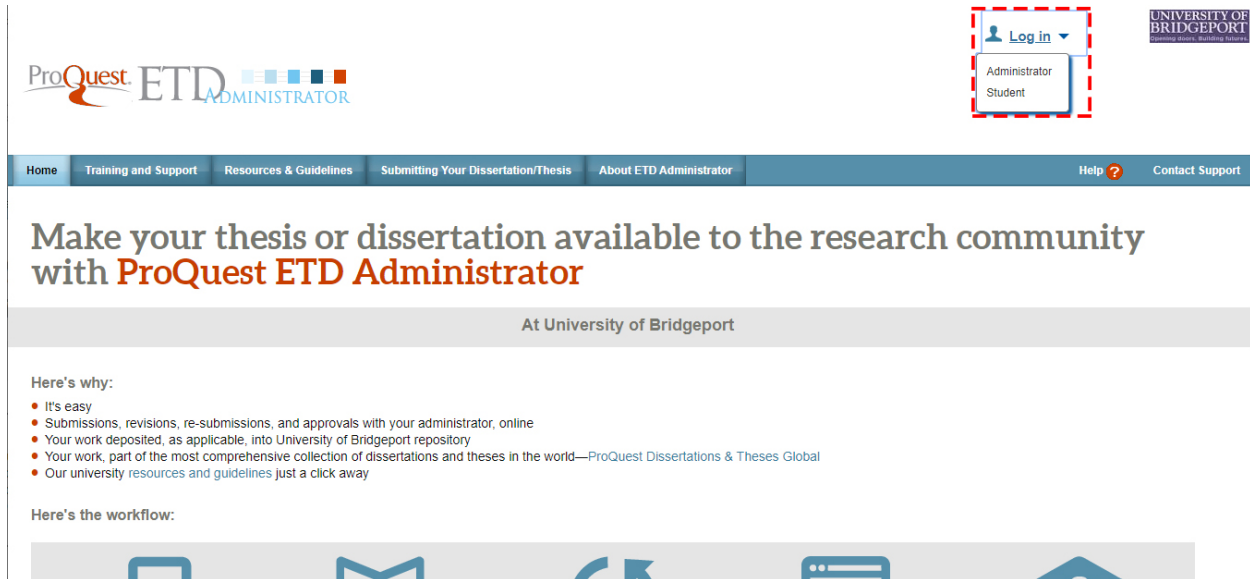

1. Login to ProQuest ETD Administrator

To submit your thesis or dissertation to ProQuest go to <https://www.etdadmin.com/main/home?siteId=672>. Once there you can login using the “Log In” dropdown and selecting “Student”. Login using your UBNNet login.



2. Start a New Submission

Once logged in you are able to create a new thesis/dissertation submission or continue working on an existing submission. To submit your thesis/dissertation click on the “Submit new dissertation/thesis” link.

Start the process of publishing to ProQuest Dissertations Publishing by submitting your completed dissertation/thesis using ETD Administrator.

You will be entering information about your dissertation/thesis, uploading a copy of your work, and ordering printed copies (if desired). Your submission will be reviewed by staff at your school before they deliver it to ProQuest.

Note: If you need to finish your submission later (for instance, if you need to update your PDF file before uploading it), you can **save your information and come back later to finish**. No information will be lost.

Some items to have on hand:

- A PDF copy of your dissertation/thesis. This must be a single file. If your manuscript is in Word or RTF format, we can convert it into a PDF.
- Abstract
- Optional Supplementary files (images, data, etc.) that are an integral part of the dissertation/thesis, but not part of the full text.
- Advisor and other Committee Members' Names
- Subject Categories - 1 - 3 that best describe your dissertation/thesis' subject area. ([Subject Category list](#))

3. Determine Publishing Options

The first thing ProQuest asks is what type of publishing type you want do through ProQuest. You can select the traditional publishing model or open access publishing model. Both publishing models are a form of non-exclusive publishing agreement so you will retain the copyright to your work and can distribute it in other places in through other forms. The traditional publishing model has no charges associated with it, though only people at institutions with a subscription to ProQuest Dissertations and Theses can have access to your dissertation/thesis through that database. The traditional publishing model also allows some potential for royalties through ProQuest, though you should read the fine print as the stipulations make it unlikely for most people to make much if anything off of it. The open access publishing model has a fee associated with it, though anyone can access your dissertation/thesis through ProQuest's database. Regardless, you still own your copyright and can distribute your document as you wish with your document. Once you decide on the publishing type you wish to use there are two other publishing options you need to decide on. First you need to decide whether or not you want to have your copy of your dissertation/thesis that is in ProQuest discoverable by major search engines. Secondly, you need to say whether or not you need an embargo on your dissertation/thesis to delay access due to a pending patent or other reason that you would need to delay the ability for people to read your work. Once you have made your decisions click "Continue".

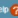

Traditional Publishing Agreement

This Agreement is between the author (Author) and ProQuest LLC, through its ProQuest® Dissertation Publishing business (ProQuest). Under this Agreement, Author grants ProQuest certain rights to preserve, archive and publish the dissertation or thesis, abstract, and index terms (the Work) provided by Author to ProQuest.

Section I. License for Inclusion of the Work in ProQuest® Publishing Program.

Grant of Rights. Author hereby grants to ProQuest the non-exclusive, worldwide right to reproduce, distribute, display and transmit the Work (in whole or in part) in such tangible and electronic formats as may be in existence now or developed in the future. Author further grants to ProQuest the right to include the abstract, bibliography and other metadata in the ProQuest Dissertations and Theses database (PQDT) and in ProQuest's Dissertation Abstracts International and any successor or related index and/or finding products or services.

ProQuest® Publishing Program - Election and Elements. The rights granted above shall be exercised according to the publishing option selected by Author on the previous Publishing Options screen, and subject to the following additional Publishing Program requirements:

- Redistribution of the Work.** Except as restricted by Author in the publishing option selected, the rights granted by Author automatically include (1) the right to allow sale and distribution of the Work, in whole or in part, by agents and distributors, and (2) the right to make the Abstract, bibliographic data and any meta data associated with the Work available to search engines and harvesters.
- Restrictions.** ProQuest will use commercially reasonable efforts to restrict the distribution of the Work as provided under the publishing option selected by Author or as later elected by Author through direct contact with ProQuest. Such election is subject to Author's Degree Granting Institution Directives (see below). With respect to restrictions requested after submission of the Work, Author acknowledges that ProQuest cannot recall or amend previously distributed versions of the Work. At Author's option, as indicated in the Register U.S. Copyright screen of the online submission process, and upon payment of the applicable fee, ProQuest will submit an application for registration of Author's copyright in the Work in Author's name. Delivery of the Work. Author shall provide to ProQuest the Work and all necessary supporting documents during the online submission process, according to [Guide 1: Preparing Your Manuscript for Submission](#).

Author represents and warrants that Author is the copyright holder of the Work and has obtained all necessary rights to permit ProQuest to reproduce and distribute third party materials contained in any part of the Work, including all necessary licenses for any non-public, third party software necessary to access, display, and run or print the Work. Author is solely responsible and will indemnify ProQuest for any third party claims related to the Work as submitted for publication.

Section II. Rights pursuant to Traditional Publishing.

Author's election of Traditional as the type of Publishing confirms Author's choice to have ProQuest publish the Work according to the Traditional Publishing option described below:

Traditional Publishing. ProQuest may exercise the rights granted under Section I above including through the sale of individual copies of the Work in tangible or electronic media and/or as part of electronic database and reference products or services.

Publishing Fees and Royalties. There is no publishing fee charged for dissertations and theses submitted through the ProQuest® ETD Administrator. Author's institution may assess additional fees. ProQuest will pay royalties of 10% of its net revenue from sales of the Work, conditioned on Author maintaining a current address on record with ProQuest. Royalties will be paid when accrued earned royalties reach \$25.00 USD. If, after 25 years, earned royalties do not accrue to at least \$25.00 USD, ProQuest's royalty payment obligation will cease.

4. Decide Whether to Include in UB's Institutional Repository

Next you need to determine whether or not you want to include your dissertation/thesis in UB's institutional repository UB ScholarWorks. Will is a place administered by UB where you can provide your work open access for increased visibility and usage of your work. Check with your department to see whether there is a requirement of your program to deposit a copy in ScholarWorks.

5. Provide ProQuest Your Contact Information

The final bit of publishing information ProQuest requests is for contact information for you as the author. This is the standard name and address form that is common throughout the internet. The unique fields to keep in mind though is the fields for ORCID, Institutional ID, and permanent e-mail. An ORCID (Open Researcher and Contributor ID) is a unique identifier that helps associate your works and differentiate you with others that share your name. This is not required to continue on but if you have one it is important to include it, or if you do not and you have many publications or expect to be publishing in the future it is worth creating one. Institutional ID is your student ID number. The permanent e-mail is a non-university e-mail that ProQuest can use to contact you after graduation.

6. Provide Dissertation/Thesis Details

Now with the publishing information dealt with you will move onto the actual dissertation/thesis submission. You start with the simple items that you already have in your document by setting the language and copying the title and abstract in. If you have a second language you would like to put a title and abstract in to help scholars from another culture or language group you can optionally include one other version of your title and abstract which is in a different language, though you can only do one of these so chose accordingly if you wish to use this function. After that you need to provide dates for when you completed your manuscript. Then you need to provide information in regards to your degree, the year you graduated, what your degree is, and which department you obtained your degree from. At this point you need to think of how you describe your work. ProQuest asks you to determine the primary subject category from their list, as well as providing you the ability to select up to two secondary categories if there are other relevant ones from the list. Then you may include up six keywords that describe your dissertation/thesis that will be used to help highlight your work in searches. Finally for this page you need to provide the names of your advisor, committee chair, and the committee members overseeing your dissertation/thesis before you can continue.

7. Upload PDF Copy of Your Dissertation/Thesis

Now you simply need to upload the PDF copy of your dissertation/thesis. You can also upload items in Microsoft Word format or as an RTF file and the system can run a conversion process on it, though if you want to know that it is formatted the way you want you should upload it as a PDF. Make sure to upload the version that was approved by your committee with whatever corrections they requested. This page is also where you would upload any copyright permissions you may have needed to obtain to use copyrighted material within your dissertation/thesis.

8. Decide on Copyright Registration

Next ProQuest asks if you would like to register your work the US Copyright Office. We should not though that given current US copyright law this is not required since your work is automatically protected under copyright at the moment of creation. As such, you can still take legal action against anyone violating your copyright, even if you do not file with the US Copyright Office. There are some reasons you may want to register your copyright, in which case you can use ProQuest's service, though you can always register it yourself at copyright.gov at a lower cost. Regardless if you do use ProQuest's services for copyright you need to let them know whether or not copyright was previous registered and if you want to them to register copyright on your behalf.
